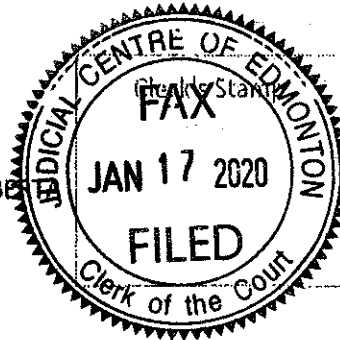



UPON THE APPLICATION of the Plaintiff/Applicant, Roland Nikolas Auer (the "Applicant"), for a procedural order establishing timelines in respect of the Amended Family Application filed by the Applicant on August 31, 2016 (the "Application"); AND UPON NOTING the consent of the Intervenor, Attorney General of Canada (the "Intervenor"); AND UPON NOTING that the Defendant/Respondent, Aysel Igorevna Auer (the "Respondent") takes no position on the Application and does not wish to have any direct involvement with the Application, in accordance with the Respondent's letter to the Court dated September 9, 2016; IT IS HEREBY ORDERED THAT:

- Any updates to the Affidavit of Professor Douglas W. Allen and/or the Affidavit of Professor Chris Sarlo shall be filed and served by the Applicant no later than February 15, 2020.

2. The Intervenor shall conduct cross-examinations, if any, on the Affidavit of Professor Chris Sarfo by no later than April 9, 2020.
3. The Intervenor shall conduct cross-examinations, if any, on the Affidavit of Professor Douglas W. Allen by no later than May 1, 2020.
4. Responses to undertakings arising from cross-examinations by the Intervenor, if any, shall be provided by the Applicant by no later than May 29, 2020.
5. The Intervenor shall file response Affidavits, if any, by no later than June 15, 2020.
6. The Applicant shall conduct cross-examinations, if any, on any response Affidavits filed on behalf of the Intervenor by no later than August 14, 2020.
7. Responses to undertakings arising from cross-examinations by the Applicant, if any, shall be provided by the Intervenor by no later than September 15, 2020.
8. The parties shall schedule a 4-day hearing (including 1 day of reading time) for the Application on the first dates available after November 30, 2020.
9. The Applicant shall file and serve primary written submissions in respect of the Application by no later than two months before the first hearing date.
10. The Intervenor shall file and serve response written submissions in respect of the Application, if any, by no later than one month before the first hearing date.
11. The Applicant may file and serve reply written submissions in respect of the Application, if any, by no later than the second Friday before the first hearing date.
12. Leave is granted such that there is no limit on the number of pages for written submissions or for affidavits filed in the Application.
13. Family Law Practice Note 2 is modified as set out herein.
14. There shall be no costs associated with this Order.
15. This Order may be executed electronically and in counterpart.


